

Resolution to recognise David Iakobachvili as an independent director

Resolution of the Board of Directors

1. Assign the status of an independent director to the following members of the Board of Directors of Sistema PJSFC:

David Iakobachvili

4. Recognise the members of the Board of Directors of Sistema PJSFC (hereinafter, "the Corporation") <...> D. Iakobachvili as independent directors despite their having formal criteria of affiliation with Sistema PJSFC as their tenure as members of Sistema's Board of Directors exceeds 7 (seven) years.

8. Recognise David Iakobachvili as an independent director despite his having formal criteria of affiliation with Sistema, since his tenure as member of Sistema's Board of Directors exceeds 7 (seven) years, based on the following:

8.1. Analysis of Mr Iakobachvili's compliance with the requirements to independent directors established by the Listing Rules of the Moscow Exchange and the Corporate Governance Code recommended by the Central Bank of Russia shows that he is not affiliated with Sistema's substantial shareholder, substantial counterparty or competitor, and the state, and is also not affiliated with the Corporation, except for his tenure as a member of the Board of Directors of Sistema PJSFC, which is 8 (eight) years.

8.2. Mr Iakobachvili has no contractual obligations with the Corporation, is party to no transactions performed by the Corporation and/or any persons/entities controlling the Corporation or controlled by the Corporation, takes no part in such transactions, and provides no advisory services to the Corporation and/or any persons/entities controlling the Corporation or controlled by the Corporation.

8.3. Mr Iakobachvili receives no monetary or non-monetary rewards from the Corporation and/or any persons/entities controlling the Corporation or controlled by the Corporation, except for remuneration and compensations payable for his work on the board of directors.

8.4. Mr Iakobachvili neither owns nor controls any material equity interest in the Corporation. Shares of the Corporation held by D. Iakobachvili represent less than 1 (one) % of the authorised capital of Sistema PJSFC, and their total market value does not exceed the threshold set by the criteria of independence of board members.

8.5. The fact that Mr Iakobachvili's tenure on Sistema's Board of Directors exceeds 7 (seven) years does not prevent him from making independent judgements in his capacity as a Board member of Sistema PJSFC.

8.6. Based on Mr Iakobachvili's record with the Corporation's Board of Directors and Board Committees, Mr Iakobachvili's stance on the matters discussed at board and committee meetings is based solely on his professional experience and knowledge and is invariably unbiased, unaided, objective and independent from the opinions of any other persons. Mr Iakobachvili does not represent the interests of Sistema's management, whose activities he evaluates critically and impartially, or of any shareholders or group of shareholders of Sistema PJSFC. Mr Iakobachvili's work as a member of Sistema's Board of Directors serves the interests of the Corporation and its shareholders.

8.7. D. Iakobachvili's extensive professional experience and vast knowledge of investment activities are crucial for the efficient work of the Corporation's Board and Board Committees. Mr Iakobachvili actively participates in the discussion of items reviewed by the Board and Board Committees and expresses his independent opinion, significantly contributing to shaping decisions made by these bodies.
